**Sub: Outcome of Board Meeting pursuant to Regulations 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI LODR Regulations**"), please be informed that the Board of Directors at its meeting held today i.e. Monday, 2 September, 2024, has *inter-alia* considered and approved the following:

➤ **DIVESTMENT OF 100% EQUITY STAKE HELD IN ITS WHOLLY OWNED SUBSIDIARY, GLOBE ALL INDIA SERVICES LIMITED ("GAISL")**

Divestment of 100% equity stake held in its Wholly-owned Subsidiary, Globe All India Services Limited ("**GAISL**") to Yatra Online Limited ("**Buyer**") for an aggregate consideration of INR 128,00,00,000 (Indian Rupees One Hundred Twenty Eight Crore only), net of Debt. GAISL is not a material subsidiary of the Company. The divestment of 100% equity stake in GAISL will be subject to the completion of conditions precedent and closing actions as specified in the share purchase agreement being executed by and among the Company, Buyer and GAISL ("**SPA**").

Post the completion of the proposed divestment, the Company will cease to hold any shareholding in GAISL, and consequently GAISL will cease to be a subsidiary of the Company.
