We are pleased to inform that the Company has commenced Cold Forgings facilities at Ramkrishna Forgings Limited - Plot No. 1988, Mouza Dugni, P.O Kolabira, Dist. Saraikella - Kharswan, Jharkhand w.e.f. 31st January, 2025 with the production capacity of 25,000 Tonnes Per Annum (TPA).

The total forgings capacity of the Company will now be 2,54,150 TPA including 25000 TPA of Cold Forgings.

Cold Forgings is a new form of forging process which has been commissioned by the Company. It is a metal working process used to shape metal without the application of heat that shapes metal at room temperature using pressure to improving the strength of the metal through strain hardening with high durability and dimensional accuracy. This method is highly valued for producing complex shapes and intricate designs. The forgings produced through this process are stronger, more ductile and more resistant to fatigue and shock with improved mechanical properties. It can also produce forgings with close tolerance and with a superior surface finish.

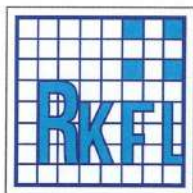
